Effective May 19, 2017, all tariffs for movements originating in Norco Saint Charles Parish, Louisiana or Garyville Saint John the Baptist Parish, Louisiana and delivering to Plantation Pipeline Junction East Baton Rouge Parish, LA are temporarily embargoed to preform emergency system maintenance. The embargoed movements are denoted by the symbol "[E]" in Items 1 and 5. Bengal requests that the temporary embargo remain in effect until a tariff filing is made cancelling the embargo. Movements to all other destinations are unaffected by this embargo.
