In accordance with the requirements of the Interstate Commerce Act and the regulations of the Federal Energy Regulatory Commission (the "Commission" or "FERC"), Bengal hereby submits for filing FERC No. 19.13.0 (the "Tariff"), canceling FERC No. 19.12.0 (Docket Number IS18-12-000).

## **Background**

The Bengal system is composed of two main lines, a 16-inch line that runs from Convent (Saint James Parish) Louisiana ("Convent") to the Colonial Pipeline Junction located at the Baton Rouge Product Station in East Feliciana Parish Louisiana ("Colonial Junction") (the "16-inch Line"), and a 24-inch line that runs from Norco (Saint Charles Parish) Louisiana and Garyville (Saint John the Baptist Parish) Louisiana to the Colonial Junction (the "24-inch Line") (collectively the "Mainlines"). Each Mainline has its own stub line that connects the line to Plantation Pipeline ("Plantation").

On October 20, 2017, Bengal filed a temporary embargo for all movements originating on the 16-inch Line and delivering to Plantation to perform emergency maintenance on the stub line that connects the 16inch Line to Plantation ("16-inch Stub Line"). After reviewing in more detail the asset integrity information for this line, Bengal has determined that the best course of action is to abandon service on the 16-inch Stub Line.

### Filing

The Tariff removes Plantation Pipeline Junction (1) (East Baton Rouge Parish) Louisiana as a delivery point for Convent originations due to the abandonment of service on the 16-inch Stub Line.<sup>1</sup> Deliveries to Plantation will continue from the 24-inch Line as those deliveries are done through a separate stub line.
