FERC No. 19.15.0 cancels FERC No. 19.14.0

In accordance with the requirements of the Interstate Commerce Act (the “ICA”) and the regulations of the Federal Energy Regulatory Commission (the “Commission” or “FERC”), Bengal hereby submits for filing FERC No. 19.15.0 (the “Local Rates Tariff”), canceling FERC No. 19.14.0. Bengal is requesting a waiver of the notice and tariff requirements under 18 CFR 341.14 and section 6(3) of the ICA in order to have FERC No. 19.15.0 be effective on November 5, 2018, on twenty five days’ notice.

Explanation of Tariff Filings

Bengal is filing FERC No. 19.15.0 to provide notice of a temporary embargo for movements originating at Norco Saint Charles Parish, Louisiana to perform maintenance on the line. Bengal requests that the embargo remain in effect until a future tariff filing is made cancelling the embargo. All other movements under the proposed tariffs are unaffected by this embargo.

Bengal is requesting a waiver of the notice and tariff requirements under 18 CFR 341.14 and section 6(3) of the ICA in order to have FERC Tariff No. 19.15.0 be effective on November 5, 2018, on twenty five days’ notice. Bengal respectfully requests granting of

this waiver in order to immediately notify our shippers of the temporary embargo. Bengal acknowledges that this tariff publication is conditionally accepted, pending a thirty-day review period.
